Hi Nikki –

I stopped by these sites yesterday on my way to some other inspections. Looks like the raised flow-through planters have been swapped out for in-ground planters (on Cobblehill at least). This is tentatively OK (the maintenance for that type of raised planters has actually been difficult over on Bunker Hill), but it means that the O&Ms will need to be updated to reflect this change and we'll need to double-check sizing and placement. I couldn't confirm whether the in-ground planters were lined, but given proximity to foundations they should be.

Hi Nikki –  
Circling back around on this one. These draft O&M Agreements look good. Just a couple of (very minor) comments below.

In addition, do you know what the status of construction/photos is? It IS possible to record the documents without photos (you would have to remove the reference to the Exhibit and make the Annual Report form Exhibit D), but we will want to be VERY sure that the final storm drain system that is built is accurately reflected in the site plan. If the as-built conditions don't match the site plan then we would need to re-record, which is why we typically ask for photos/wait for completion before recording. However, if time is tight I did want to make it an option.
