III. Public Service Announcements

PSAs were brought to the attention of the CAPC Committee Team to discuss the committee's involvement in preventative measures through outreach and education. PSAs would be discussed in the workgroups. Recent Incidents included drownings and falls from 2nd story windows.

Current Efforts:

The Stanford Trauma Team has led campaigns in the past. Dr. Egge will reach out to determine a potential collaboration.

An Electronic road sign is posted on the 101 signaling dangerous water conditions Further Education is needed on the differences between swimming in ocean waters versus a pool.

Prevention efforts for SIDS has been effective. There have been no recent reports of deaths due to SIDS.

IV. Child Abuse Prevention Month – April 2025

This is an Annual event held in April with the purpose of drawing attention to the work being done in the community to address the issue.

2024 CAP Recognition Event included:

- BOS proclamation
- Presentation to BOS by Eric V. & Dr. Egge on current work in CAPC done by their respective programs
- Flag raising commemorating/memorializing children who lost their lives due to child abuse *Last Friday in April
- Distribution of Child Abuse Prevention materials.

 Debra obtained materials: i.e. blue ribbon pins, posters, stickers; from Partners in Prevention,

 (Blue Ribbon Campaign Month) and shared amongst partners.

2025 CAP Recognition Event Planning

Ideas resulting from Last Event:

- Additional child abuse prevention activities/events in the communities
 - Family wellness event, focusing on wellbeing and wholeness
 - Introduction to Protective Factors
 - Outreach by teaching positive parenting
- Highlighting resiliency and family experiences
- Sponsorship and grants for an event
- Offering protective program resources
- Creation of an annual calendar to keep the message of CAP in the community beyond the CAP Month

• Encourage greater participation from providers and community

Establish a local campaign to change the messaging and stigma about the child welfare system. Work would be done by a collaborative of current providers. A discussion about protective factor measures could serve as a starting point for providers to begin to address the issue. GBA CAPC creates pocket guides to distribute to families, outlining protective factors and is customizable to add San Mateo CAPCs own protective factor measures.
